- 1. Copy of Identity card.
- 2. Signed consent for the use of copies of personal documents (attached document);
- 3. Ownership list (property certificate) for the plot where the farm is built.
- 4. Rental agreement of reported parcel of straight bloodline (if the parcel is rented of inherited);
- 5. Certificate that proves the bloodline in the family (if the plot is inherited).
- 6. Certificate of registration in the register for identification of animals with number of cattle (issued by FVA- Food and Veterinary Agency).
- 7. The application for direct payments (subsidies) for the year 2025.

Documents must be submitted in two copies, one in original and one copy for each document.

If the candidate is selected, participation in the training program is obligatory and is a prerequisite to be considered for the grant scheme.
