

Call for expressions of interest

Over the years PAMKOS has proven its professional capacity in becoming the unit association which represent the interests of all its members (which are public waste management companies), engaging in advocacy activities, development research and enhancement of its members, and their ability to provide professional, competitive, sustainable and environmentally friendly services; and at the same time promoting the public waste management sector in Kosovo. In addition to fulfill its mission, PAMKOS with the support of the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH is being support to develop regulatory capacities and their updating referring to the further development of the association and in accordance with the amended laws.
